ATTACHMENT TO THE ARTICLES OF INCORPORATION

OF

WOMEN IN WATER SCHOLARSHIP FUND

This Attachment is incorporated into the Articles of Incorporation for Women in Water Scholarship Fund, a nonprofit corporation established pursuant to the provisions of the Colorado Revised Nonprofit Corporation Act (the **Act**):

- 1 DURATION. The Corporation will have perpetual existence.
- 2 PURPOSES AND POWERS.
- 2.1 PURPOSES. Women in Water Scholarship Fund (the Corporation) is organized and shall be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) and Section 170(c)(2) of the Internal Revenue Code, all in accordance with the provisions of Section 509(a)(3) of the Code. All references in these Articles of Incorporation to sections of the Internal Revenue Code or the Code are to the Internal Revenue Code of 1986 and include any provisions thereof adopted by future amendments thereto and any cognate provisions in future Internal Revenue Codes to the extent such provisions are applicable to the Corporation.
- 2.2 POWERS. In furtherance of the foregoing purposes and objectives (but not otherwise) and subject to the restrictions set forth in Section 2.2 of this article, the Corporation shall have and may exercise all of the powers now or hereafter conferred upon nonprofit corporations organized under the laws of Colorado and may do everything necessary or convenient for the accomplishment of any of the corporate purposes, either alone or in connection with other organizations, entities or individuals, and either as principal or agent, subject to such limitations as are or may be prescribed by law.
- 2.3 RESTRICTIONS ON POWERS.
- (a) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, any private individual, including but not limited to its directors, officers, employees, independent contractors, or other persons; except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the Corporation and to make payments and distributions in furtherance of the purposes set forth in <u>Section 2.1</u> above.
- (b) No substantial part of the activities of the Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation. The Corporation shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- (c) Notwithstanding any other provision of these articles of incorporation, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax as an organization described in section 501(c)(3) of the Code, or by a corporation, contributions to which are deductible under section 170(c)(2) of the Code.
- 3 INTERPRETATION. As used in these articles:

- 3.1 References to "charitable organizations" or "charitable organization" mean corporations, trusts, funds, foundations, or community chests created or organized in the United States or in any of its possessions, whether under the laws of the United States, any state or territory, the District of Columbia, or any possession of the United States, organized and operated exclusively for charitable purposes, no part of the net earnings of which inures or is payable to or for the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda or otherwise attempting to influence legislation and which do not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidates for public office. It is intended that the organization described in this Article 3 shall be entitled to exemption from federal income tax under Section 501(c)(3) of the Code.
- 3.2 The term "charitable purposes" shall be limited to and shall include only religious, charitable, scientific testing for public safety, literary, or educational purposes within the meaning of the terms used in Section 501(c)(3) of the Code but only such purposes as also constitute public charitable purposes under the laws of the United States, any state or territory, the District of Columbia, or any possession of the United States.
